## Eligibility Requirements to take CBAP® Exam

In order to qualify for the CBAP® exam, a candidate must meet certain requirements as specified by IIBA®. The eligibility requirements are:

### 1. **35 professional development hours (within the last 4 years):**

Candidate must have earned 35 professional development hours, which are aligned with A Guide to the Business Analysis Body of Knowledge® (BABOK® Guide) Knowledge Areas and also meet the following educational and training standards that enable the transfer of learning and



assessment:

- A moderator or facilitator for the session who leads the group/individual through the material.
- Measurable learning objectives directly applicable to the role of the business analysis professional.
- Opportunities for students to interact with the material and ask questions.
- Opportunities for students to practice the task or objective being presented and be assessed by the facilitator/moderator.

**Please Note:** Skillcubator is an IIBA® Premium-Level Endorsed Education Provider (EEP) and by taking our CBAP® certification course, you automatically earn 35 Professional Development Hours to qualify to take CBAP® certification exams.

## **2. 7,500 work history hours (within the last 10 years):**

A candidate must have a minimum of 7,500 hours of business analysis work experience within the last ten years. Relevant work experience should be in business analysis domain, which includes tasks such as requirements elicitation, analysis, documentation, requirements management, stakeholder management etc.

Additionally, within this experience, a minimum of 900 hours must be completed in 4 of the 6 BABOK® Guide Knowledge Areas, for a total of at least 3,600 of the required 7,500 total.

## **3. 2 references**

A Candidate must arrange for two professional references, who have been known to the candidate for at least 6 months. Professional reference can be either CCBA/CBAP® certification holder, a career manager or an internal or external client.

*Please Note: References MUST provide an email with company domain. Personal email (Gmail, Yahoo, Hotmail etc.) are NOT accepted.*

## **4. Agreement to the CBAP® Code of Conduct:**

Candidate must agree to accept/adhere to the CBAP® Code of Conduct, which outlines ethical and professional behavior expectations for CBAP®-certified individuals.

## **Who Should Attend?**

- A business analysis practitioner, who meets the minimum criteria to sit for the CBAP® exam (please see above) and desires to gain credibility in the field of business analysis and earn higher remuneration should attend the bootcamp.

- Additionally, anyone who qualifies to sit for CBAP® exam, irrespective of their title, and is interested in earning CBAP® should attend the bootcamp.
